

WIN RECHARGE CREDIT – THE PAKO FESTA

1. Information on how to enter and prizes forms part of these conditions of entry. Submission of entry is deemed acceptance of these conditions of entry.
2. Employees (and their immediate families) of the Promoter, Lebara resellers and agencies associated with this promotion are ineligible to enter.
3. Competition commences at 09:00 (AEST) on 15 February 2010, and closes at 16:00, 27 February 2010 (AEST) (“Competition Period”). The draw will take place at the Pako Festa, Pakington Street, Geelong NSW 3218 (the “Event”), at 16:30 (AEST). To enter, Eligible Entrants must, during the Competition Period:
 - purchase a Lebara Mobile Prepaid SIM Starter pack or Lebara Mobile Recharge scratch voucher from Lebara Mobile staff during the Competition period; and
 - Complete the Entry form for the draw at the Lebara Mobile stand at the point of purchase.
4. Only one entry permitted per person and entrants can only enter in their own name. The Promoter reserves the right to verify the validity of entries and entrants (including an entrant's identity, age, and address) and to disqualify any entrant who submits an entry that is not in accordance with these conditions of entry, who tampers with the entry process or who submits an entry that the Promoter, in its sole discretion, deems to be offensive, inappropriate, defamatory or otherwise not in keeping with the spirit of the competition. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
5. Incomplete, indecipherable, or illegible entries will be deemed invalid. Any incorrect entrant details submitted may render the corresponding entry invalid. If there is a dispute as to the identity of an entrant, the entrant will be deemed to be the person in whose name the corresponding Prepaid SIM is activated on.
6. The winners will be selected based on a lucky draw from the entry barrel at the Lebara stand at the Event at 16:30 (AEST). The draw will be conducted by a Lebara representative and winners must be present and will be notified at the time of the draw on the day of the Event. The winners must provide proof of identification to claim their prize, and consent to their name being published on the Lebara Mobile website. In the event of the prize winner not being present at the draw, the prize or that element of the prize will be forfeited by the prize winner and neither cash nor any other prize will be awarded in lieu. In the instance of a prize being forfeited, the prize will be redrawn until a winner is selected. The winners, as determined by the Promoter, in its sole discretion, will be drawn from the barrel and will win:
